

Attention Cherry, Grant, Hooker, and Thomas County Irrigators



Flow meters are an important tool for your operation. Meters give producers information about the total amount of water applied for irrigation. The NRD also uses this data to determine the amount of water being withdrawn from the aquifer across the district. Effective groundwater management begins with accurate water use measurements. All active high capacity wells associated with certified acres, those with a pumping apparatus, must be equipped with a flow meter. Subdistricts 1-3 (Cherry, Grant, Hooker, and Thomas Counties) wells need to be metered by May 1, 2020. If you have recently installed a flow meter, please call us at 308-645-2250 so we can send a technician to inspect it.

Chemigation Training and Permits

Before an irrigator can begin chemigation, state law requires a permit to be obtained from the local NRD on an annual basis. Permit fees through the ULNRD are as follows: Renewal Permit: \$30.00, New Permit: \$60.00, Special Permit: \$60.00 and Emergency Permit \$250.00. Inspections will continue to be made on a three year cycle; new and modified systems must still have an inspection prior to injecting fertilizer or pesticides. Renewal permits and fees are due in the office of the Upper Loup NRD no later than 4pm CT on June 1st.

If you plan to apply chemicals, you MUST ATTEND one of the courses and pass a written exam to be certified. Certification is good for four years. Area training dates: **April 9** at 9 am CT, **May 8** at 1 pm CT, and **June 6** at 1 pm CT. The location of these classes will be held at 402 W State Farm Road, North Platte, you may contact Chuck Burr at 308-696-6783 for more information.

ULNRD Welcomes New Board Directors

Noxious Weed Spraying

The legal description of a noxious weed is any plant designated by a federal, state or county government as injurious to public health, agriculture, recreation, wildlife or property. More commonly they are defined as a plant that grows out of place and is competitive, persistent, and pernicious.

Regardless of which weed you are trying to manage, it's important to continue yearly management as skipping a year can cause the noxious weed to re-infest rapidly. Persistence is the key to any successful weed control program.

In Nebraska, you are legally required to control noxious weeds on your property. The common noxious weeds on the Nebraska State list include: plumeless thistle, musk thistle, diffuse knapweed, spotted knapweed, Canada thistle, leafy spurge, purple loosestrife and saltcedar. Fortunately, not all of these weeds are found in our district. To help with the battle of those found in our area (leafy spurge, Canada thistle, musk thistle), the Upper Loup Natural Resources District provides cost share funds for BOTH fall and spring treatment to landowners in the NRD area. Funds are available to cover 50% of the cost of approved chemicals up to \$500 per landowner. Applications can be found on our website or you can contact our office.

The ULNRD has 2 no-till drills available for rent: a 10 foot Great Plains minimum till drill and a 20 foot HayBuster No Till Drill. Producers wanting to purchase and apply restricted use pesticides on their properties must obtain private applicators licenses. Trainings cost \$40 per person. Local trainings will be held: April 3rd in Valentine and April 9th in North Platte. Private licenses can also be obtained by completing a self study course. This course will cost \$75.
